1. Please refer to your letter.No Nil dated 10.12.2008 received by this office on 15.12.08 on the subject stated above.
2. As per the authorization given by the Airports Authority of India, Head Quarters, New Delhi, vide letter No: AAI/20012/670/2008-ARI (NOC) dated 07.10.2008 this office has no objection to the construction of the proposed Residential Complex by M/S Telugu Film Producers mutually aided Co-Op Housing Society Ltd, Rep by its Secretary, Sri A Suryanarayana, Here in after referred to as the applicant at location on on open land in Survey No. 239 & 240, Kokapet Village, Rajendra Nagar Mandal, Ranga Reddy Dist, A.P. (Co-ordinates 17° 24' 20" N 078° 19' 00" E) to a height of (in Fig) 85.00 Mts AGL (in words) Eighty Five Decimal Zero Mts AGL above ground level so that the top of the proposed structure when erected shall not exceed 565.00 Mts AMSL (site elevation) PLUS (+) 85.00 Mts AGL (Height of the structure) = 650.00 Mts AMSL. (Six Hundred Fifty Decimal Zero Mts AMSL).
3. This No Objection Certificate is being issued on the express understanding that the site elevation reduced level (height above mean sea level 565.00 Mts AMSL relative location of the proposed building/structure and its distances and bearings from the ARP/runway ends, as tendered by the applicant(s) are correct. If, however, at any stage it is established that the said data as tendered by the said applicant is actually different that the one tendered and which could adversely affect aircraft operations, the structure or part(s) thereof in respect of which this 'No Objection Certificate' is being issued will have to be demolished at his own cost as may be directed by the Airports Authority of India. The applicant(s) is/are therefore advised in his/their own interest to verify the elevation and other data furnished for the site before embarking on the proposed construction.
4. The issue of the 'No Objection Certificate' is further subject to the provisions of section 9-A of the Indian Aircraft Act, 1934, and those of any notifications issued there under from time to time and under which also the applicant may be called upon by the Airports Authority of India to demolish in whole or in part the structure now being authorized vide this 'No Objection Certificate'.
5. No Radio/TV Antenna, Lightening Arresters, Staircase, Mumtee, Overhead Water Tanks and attachment and Fixtures or any kind shall project above the height indicated in para 2 above.
6. The use of electric fired or oil fired furnace is obligatory, within 8 KM of the aerodrome.
7. This certificate is valid for a period of **Five years from the date of issue**. If the building/structure/chimney is not constructed and completed within the above-mentioned period of 5 years, he will be required to obtain fresh 'No Objection Certificate' from the ED (ATM), AAI, and New Delhi. The date of completion of building/structure/chimney should be intimated to the ED (ATM), AAI Hqr The General Manager (Aerodromes), AAI, Chennai Airport, Chennai -27 and/ Airport Director, AAI, Hyderabad Airport, Hyderabad -16.
8. No light or a combination of lights which by reason of its intensity, configuration or color may cause confusion with the aeronautical ground lights of the airport shall be installed at the site at any time during or after the construction of the building. Day & Night markings with secondary power supply may be provided as per ICAO standards.
- 9 This certificate is applicable only for the purposes of clearance from the angles of air safety and for height clearance only. This issue of NOC is without prejudice to, a separate clearance to be obtained for any commercial activity on the construction proposed on AAI land (if applicable) for which liaison may be effected with the concerned department. This is therefore not necessary, for construction on non-AAI land.
