Sri C. Kalyan requested the General Body that all the Members must try to pay their instalments themselves and request as well their friends and relatives in the Society. He requested that the Members may apply for bank loan it is easy to get if we give required documents for bank. Sri V. Niranjan Babu responded that we will give guidance to the Members going for bank loan. Sri T. Gopala Krishna suggested Members to see the Model House if they have not seen earlier.


